Approval of the Minutes from June 26, 2022

Motion to approve by Susan Kuntz. Seconded by Jonathan Flowers. Motion passes.

Officer Reports

A. President

- 1. Thank you to Jonathan for your DSPF work. Thank you to Evan on organize the competition. Thank you to Ed for dinner assistance. Maria has been a wonderful host.
- 2. Reflecting on the Summer conference. Trying to find new leaders, hope to fill these vacancies, a reminder to take care of each other and a call for each member to aim to provide solid mentorship for those that follow.
- 3. Leadership Summit: Amanda and Wendy, president elect, attended the summit and found it refreshing and fun. National Conference has affordable lodging. Local Presidents Zoom meeting was held, was successful, and presidents have asked for more. MTNA has mentioned specific chairs could be deleted, and instead states could create "task forces" that focus on certain topics. At this time, Amanda's recommendation is not to delete these at this time. There seems to be a national movement to group topics by areas of concern. Awards need to nominate a Teacher of the Year for the state, but also they can be nominated for nationals. Our local association, Main Line, has been selected as a national winner for Local Association of the Year! Will be announced officially at the National Conference.

B. Treasurer

- 1. In January we will know the growth on our "Annuity 1"
- 2. Budget: The Conference fees are included on the report.
- 3. Dues: Low point in the year. We should see this increase after renewals come in April. Should we consider an increase in our dues which are now at \$45? Membership is a bit down. There is some concern about members lack of interest due to our fees (particularly a concern for the local associations).
 - Motion by Wendy Bachman increase state dues from \$45 to \$50- and reassess in 2025. Seconded by Steven Smith. Motion passes (one opposition).
- 4. Motion by Mary Lynne \$5/hr raise for OCE Joy Carroll. Seconded by Jonathan. Motion passes.

C. Local Association

Proposed discussion – main take from meeting in June. Concern about distance to the
DSPF from all around the state. Could a committee be formed to consider this? Steven –
we tried this, but it didn't work out – there was concern that it wasn't a "state" event.
Perhaps tie in with the college that is hosting – could have a faculty sampler recital. This
discussion is tabled for the time being.

1. 428 members. 15th largest in the country, down from 13th last year. Some of the collegiate numbers differ from the report sheet. Main Line is our largest chapter. A few chapters increased in number. National membership is down. Should there be a task force on membership for the local associations – how to grow? Could there be grant money to help train, or hire, web design help for Local Associations?

Should we consider adopting a *state standard* of student progress of performance. Could there be interest in using the RCM as a model? Several states have adopted this. There is concern that this would be the "exclusive" model endorsed by the state, when there are other certifications available as well, including Guild of Piano Teachers. Teachers could make this choice regardless of any endorsement by the state. Maybe we could ask RCM if they could change their wording that would not include our endorsement as an entire state for RCM as the exclusive standard. Would they be interested in serving just as an advertiser rather than an exclusive endorsement? This is a source for further discussion.
